

AGREED MINUTES

1. A delegation representing jointly the Governments of the Kingdoms of Denmark, Norway and Sweden and a delegation representing the Government of the Arab Republic of Egypt met during ICAN2012 at Jeddah on 9 December 2012 to discuss their civil aviation relations.

The talks were held in a friendly and cordial atmosphere.

The delegations are listed in Appendices I and II.

2. The delegations agreed upon and initialled new Air Services Agreements (ASAs) between Egypt and Denmark, Norway and Sweden, respectively, as well as a MoU on designation of airlines and on the co-operation regarding Scandinavian Airlines System (SAS). These texts are attached as Appendices III, IV, V and IV.
3. The delegations agreed that they would seek speedy internal approval of the ASAs and the MoU so that they can be signed and enter into force without undue delay.
4. Recognizing that completion of the formalities for entry into force of the ASAs and the MoU may require some time, the delegations also agreed that they will give immediate practical effect to the draft ASAs and the draft MoU to the extent possible under national law, pending the entry into force of the ASAs and the MoU.
